### Spring Elections, April 5, 2022

The offices involved in spring elections are non-partisan races. These include county supervisors, judgeships, school boards, aldermen and other local offices. While considered non-partisan, it is still very important that voters consider the governing philosophy of the candidates. Political philosophy of those elected will determine how we are governed at the local level. You, along with the conservatives on Main Street, have certainly noticed that school board and other local political decisions have had a huge impact on all our lives in the past couple years. In response to this, our intention in this newsletter is to help you to learn about and find the right candidate for you, a Wisconsin conservative, regardless of your party affiliation. The Winnebago GOP sees its role in non-partisan elections as assisting Wisconsin voters to identify voices tending toward the conservative end of the spectrum.



### Judgeships

Courts decide what really happened and what should be done about it. They decide whether a person committed a crime and what the punishment should be. They also provide a peaceful way to decide private disputes that people can't resolve themselves. Appeals courts hear cases previously heard in lower courts only when the lower court decision is appealed. Courts at higher levels determine if laws passed by the legislative branch comply with the constitution.

The Founding Fathers of the United States vested *judicial power* (the power to interpret the laws and decide concrete factual cases) with the courts. **Legislative power**, the power to actually make law, is vested in the **legislative** 

**branch**, not the judicial branch. When they realized many of their policies could not get majority support liberals have turned to legislating through the courts by means of on well-placed individual.

### District II Court of Appeals.

The Court of Appeals is the state's intermediate appellate court. The court is composed of sixteen judges from four districts headquartered in Milwaukee, Waukesha, Wausau, and Madison.





San Francisco residents overwhelmingly approved of a vote Tuesday to recall three of the city's school board members, election officials said. Critics, including San Francisco Mayor London Breed, argued the members — school board President Gabriela López, Vice President Faauuga Moliga and Commissioner Alison Collins — pushed progressive politics rather than act in the best interest of children during the pandemic, and voters agreed, according to the San Francisco Department of Elections.

### From the Gableman report: Zuckerbucks

The Cities of Milwaukee, Madison, Racine, Kenosha and Green Bay entered into an agreement with Center for Tech and Civic Life (CTCL). In the agreement, the Cities took CTCL's money to facilitate in-person and absentee voting within their respective city. . . . . The CTCL agreement facially violates the election bribery prohibition of Wis. Stat. § 12.11 because the participating cities and public officials received private money to facilitate in-person or absentee voting within such a city. Any similar agreements in the 2022 and 2024 election cycle would also be prohibited election bribery. **Gableman report, Chapter 1, P 17.** 

### From the Gableman report: Drop boxes

"In Wisconsin, election officials' unprecedented use of absentee ballot drop boxes facially violated Wisconsin law. (Editor's interjection: Said the existing law going into 2020). This practice of unlawful absentee ballot drop boxes was particularly pervasive in the cities of Milwaukee, Madison, Kenosha, Racine and Green Bay. These bulk absentee ballot drop boxes were privately financed by Center for Tech and Civic Life (CTCL) (i.e., Facebook's Zuckerberg). The WSVP (Wisconsin Safe Voting Plan) and CTCL's grant acceptance letter incorporating the WSVP is the agreement in which the city agreed to take CTCL's money to purchase and place absentee drop boxes in targeted neighborhoods. App. 10, 16-17. . . . . The use of absentee ballot drop boxes has been successfully challenged in state court as being unlawful." # From the Gableman report: Concerning 100% voter turnout in some nursing homes in the 5 Zuckerberg cities (Green Bay, Madison, Milwaukee, Kenosha, Racine).

Contrary to statements made by several groups and media sources over the past months, the OSC has uncovered evidence of election fraud in the November 2020 election. Rampant fraud and abuse occurred statewide at Wisconsin's nursing homes and other residential care facilities in relation to absentee voting at these facilities. This fraud and abuse was the ultimate result of unlawful acts by WEC's members and its staff, the end results being: 1. Residents were illegally assisted with "marking" their ballots by nursing home staff and administrators; 2. Absentee ballots for residents were illegally handled by facility staff and administrators; 3. Resident absentee ballots were illegally "witnessed" by nursing home staff and administrators; 4. Suspected forgery of resident signatures by nursing home staff and administrators; 5. Improbably high voting rates for residents at nursing homes; and 6. Ballots cast by residents— 1. Where those residents were unaware of their surroundings, with whom they are speaking at any given time, or what year it is; and/or --- 2. Where those residents' right to vote had been taken away by court order because they have been adjudicated as mentally incompetent. Through these acts, the members and staff of WEC mandated widespread election fraud to take place where our most vulnerable adult citizens reside. **Gableman report, Chapter 7, P. 80.**

President Joe Biden's Supreme Court nominee, Judge Ketanji Brown Jackson, admitted on a questionnaire for the U.S. Senate Judiciary Committee that she had authored a paper criticizing the "excessiveness" of sex offenders' punishments, which she said could be "unfair and unnecessarily burdensome."

Jackson authored "Prevention Versus Punishment: Toward a Principled Distinction in the Restraint of Released Sex Offenders," which was published anonymously in 1996 by Harvard Law Review. She did not disclose her authorship until the Senate committee asked her to list published writings as part of her nomination.

She argued that "courts have been unable" to differentiate between "preventive" and "punitive" punishments for sex offenders, according to the note obtained by the <u>American Accountability Foundation</u>.



### Good news, Bad news

### (This is going to take a while)

**First, the bad news**: In 2020, in the name of public safety. COVID was used as an excuse for Wisconsin public officials to violate our own state's voting laws. You probably remember absentee ballots sent out to anyone and everyone whether requested or not because everyone was to be considered permanently confined. No voter ID was required to fill out and return any of these ballots. In certain cities, Zuckerbucks were paid, and worse, ACCEPTED by some municipal officials to grant access or outright control of the absentee ballots to outside activists not employed by the city. Encouraged by Joe Biden's campaign **Vote in the Park** events were held in Madison outside the legal date limits established for voting. And, the focus of this tirade, **unsupervised voter drop boxes were approved and proliferated around the state.** In quick summary, we flooded the state with absentee ballots, we negated the voter ID requirement, and we accepted absentee ballots from anonymous people day and night for weeks with **NO PROVISIONS FOR CHAIN OF CUSTODY.** To me, that is all pretty bad news.

**More bad news:** In the 16 or so months since the 2020 election, little was officially done to return to a lawful state. What do you expect with Tony Evers as Governor and the quietest guy in the country, Josh Kaul, as Attorney General?

What do you expect with a "bipartisan" Wisconsin Election Commission, and a WEC Chairman that approved the acceptance of Zuckerbucks without informing the rest of the commission that the matter was under consideration at all? What do you expect when our State House (including some "Republicans") has done little to reclaim Legislative authority over elections and election law as called for by the State Constitution?

**Now, for a little GOOD news:** On January 13, 2022, a Waukesha County Circuit Court Judge prohibited the use of absentee ballot drop boxes. In other words, he ruled to uphold State Law. This was Judge Michael Bohren, for those of you looking for an honest man. **"State statutes simply do not permit the Election Committee to allow drop boxes,"** Bohren said in his ruling.

**Of course, then there was some more BAD news:** The League of Women Voters appealed Judge Bohren's agreement with state law, arguing that the primaries were just a month (February 15), away so the change of rules might be unfair . . . (**Editor's note**: to all of those that may prefer to disrespect the law, I guess.) Guess what? The District 4 Court of Appeals agreed that it was a scandal to enforce our laws, and overruled Judge Bohren's decision.

Now, back to the GOOD news: The matter was then taken to the State Supreme Court.

And then, the BAD news: The Supreme Court agreed to let the drop boxes be used for the February 15 primary

And, back to the GOOD: Drop boxes cannot be used in the actual spring election on April 5.

BUT the Supreme Court MAY STILL RULE OTHERWISE in the coming months before the November elections.

- In the editor's humble opinion, we conservatives must make three things happen:
  - 1. Contact our Wisconsin Republican legislators and insist they STAND UP!
  - 2. Get rid of Evers in the fall! and
  - 3. Elect an Attorney General that will ENFORCE THE LAWS that have been broken by both private manipulators and government officials. We MUST start enforcing the laws that we pass. Make the perps pay a price.

Since then, he has shut down new petroleum exploration permits on Federal lands. So, Psaki claims there are 9,000 leases issued that have not been fulfilled. Of course, the truth is the permits to drill on those leases are being withheld, and exploration is a huge investment and takes time to stage in an EFFICIENT way. And, who's to say at this point that a successful exploration site will be allowed to produce the oil that might be found?

With his foot standing on OUR gas line, Biden asked the Saudis to increase oil production for the benefit of the American public. No dice. Then he asks IRAN to help us out – through a Russian intermediary. And, then of course, he asked failed communist Venezuela to help out. The bill came due when we remembered that we are buying RUSSIAN oil and are afraid to stop even though we are blatantly financing Russia's war. Then Biden digs into our savings account and pulls out another THREE DAYS worth of oil from the Strategic Petroleum Reserve. We raid our piggy bank instead of going back to work to fulfill our needs.
