Legislative Action concerning Election Integrity

The election cycle and our faith in the election process itself suffered from many irregularities in 2020. COVID was used by many municipal agencies, and the Wisconsin Election Commission in particular, to authorize procedures and activities that violated established law and were not approved by the legislature as required by state law.

Since the election, many of us have impatiently demanded that the Republican controlled legislature do something about these travesties before the next election cycle. At this point, many of us are not only disappointed at the pace of fixing our election process, but also worried that the next and future elections will have the same shadow cast over them.

It is a FACT that existing laws were broken in the 2020 election. There has not been, nor will there be any cost to those who broke those laws, including the encouragement of illegal activities by WEC officials, until we have a State Attorney General that stands for law and order and does his job for the **RULE OF LAW**, which serves the people.

The following is a description of where efforts to correct our electoral procedures lie in terms of the Republican controlled legislature vs Tony Evers. While there were many other pieces of legislation that went to committee or were considered, you will find that this group of legislation addresses the areas of grave concern to those of us expecting and demanding fair elections. This listing is a testimony to two things. 1) Both houses of the Wisconsin legislature have, in fact, addressed these critical electoral issues since the 2020 election; and 2) Nothing is going to happen **UNTIL WE VOTE TONY EVERS AND HIS ATTORNEY GENERAL JOSH KAUL OUT OF OFFICE IN 2022.** Message received?

For the next election, we conservatives in Winnebago County urgently ask our elected legislators and the Republican Party of Wisconsin to step forward **BEFORE THE ELECTION** when extralegal actions are announced and before they affect the ballot count on election day. Do you hear us, **ROBIN VOS**? State Senators Dan Feyen and Roger Roth; Representatives Mike Schraa, Rachael Cabral-Guevara, and Dave Murphy? Because this is a fair elections issue, central to our democratic system, I should be able to also ask the same of Gordon Hintz and Lee Snodgrass. Alas.

Wisconsin Senate Bill 203

Effect: Absentee ballots can be returned to a collection site, but that site must be staffed by the clerk or an employee of the clerk. The site must be in a public area. The collection point can only be operated during a two-week period before the election. Absentee ballots can only be delivered by the voter himself, by immediate family, or by an appointee. A person would be limited to delivering no more than two absentee ballots.

Result: Vetoed by Governor Evers

Because: The bill would limit the assistance that could be provided to an absentee voter such as was provided during the COVID epidemic; The bill would require those returning absentee ballots to be a Wisconsin voter and would limit such individuals to delivering no more than two absentee ballots.

Editorial comment: In 2020 in Wisconsin, WEC determined it was appropriate to blanket the state with unrequested absentee ballots, and to multiply the number of drop boxes to overcome the COVID pandemic. See the link.

Wisconsin Senate Bill 204

Effect: Absentee ballots must be requested for each election and cannot be sent out to individuals that did not request them. Voter Identification must be provided with the absentee ballot request. Clerks must post hourly updates of absentee ballot showing the numbers received, returned, and remaining to be counted. The condition of "indefinitely confined" is limited in that the individual must document this yearly.

Result: Vetoed by Governor Evers

Because: The bill requires a voter to apply for an absentee ballot for each election. Clerks will no longer be allowed to send out absentee ballots prospectively. Voter identification requirements are burdensome. It is too much work for the clerks to stay late to provide hourly updates on absentee ballot counts.

Editorial Comment: Senate Bill 203 addressed the unrestrained access (and unaccountability) of drop boxes. Senate Bill 204 goes after the blanketing of the state with unrequested absentee ballots. Note that blanket distribution of absentee ballots was one of the required criteria for a local government to obtain election assistance funds from Mark Zuckerberg

Wisconsin Senate Bill 205

Effect: Administrators of long-term care facilities must notify relatives of the times when absentee voting assistants or special voting deputies will be at the facility, thus enabling family members to be present at the time of voting. The period for voting at the long-term care facilities is moved forward one week and must conclude by the 6th working day prior to the election instead of the 1st day prior to the election. The following would now be considered as Class I felonies: (1) influencing a resident to apply for or not apply for an absentee ballot; (2) influencing a resident to cast or refrain from casting a ballot; or (3) influencing a resident's decision for whom to cast a ballot.

Result: Vetoed by Governor Evers

Because: There is no reason stated in the bill for completing long-term care facility voting on the 6th working day before the election. This limitation shortens the currently allowed voting period. The bill changes the long-term care administrator's duty from allowing them to contact relatives if the resident so requests, to requiring them to contact relatives to notify them of voting at the facility.

Editorial Comment: If you recall, dozens of assisted living and memory care facilities in Wisconsin had 100% voter turnout. Cemeteries in Chicago have come close to, but have never matched this handsome turnout.

Wisconsin Senate Bill 207 / Wisconsin Assembly Bill 173

Effect: Makes it illegal for government officials within Wisconsin to accept money and/or grants from outside groups to use in the administration of elections. The bill generally prohibits counties and municipalities from applying for or accepting any donation or grant of private resources for purposes of election administration. Local units of government would not be allowed to enter a contract related to election administration if the contract contains any requirement governing election administration, requires the repayment or return of any private resources used for elections, or transfers any duty or power not authorized under state law.

Result: Vetoed by Governor Evers

Because: "I am vetoing this bill because I object to restrictions on local governments potentially using supplemental funding for election administration."

Editorial Comment: In other words, Zuckerbucks. Here is a win for YOU. At least for the 2022 election. Your outcry has something to do with this. It was – too brazen. Zuckerberg Ends Controversial Grants to Election Offices (theepochtimes.com) PS: See Good News, Bad News below

Wisconsin Senate Bill 210

Effect: Requires that poll observers be provided unimpeded view of voting and recounts from a position not more than 3-feet from the activity. The old law allowed observers to be positioned up to 8-feet from the voting activity. The bill also eliminates the requirement to include the organization to which the observer belongs on the observer's name tag.

Result: Vetoed by Governor Evers

Because: I am vetoing this bill because I object to the reduction of distance between election observers and tables where election activities are occurring. Under current law, election procedures specify that the distance is a minimum of three feet and a maximum of eight feet which allows observers sufficient proximity to ensure election procedures are being followed

Editorial Comment: How good are you at seeing the details from 8-feet? If I recall correctly, 8 feet between the observers and the voting in some areas of the country was wide enough that walls and curtains were inserted between the two.

Wisconsin Senate Bill 212

Effect: Curing (i.e., correcting supposed errors in a ballot to make it into a legal ballot) of a faulty absentee ballot by anyone other than the voter himself would be a misdemeanor offense. The law would also prohibit counting a faulty ballot if there is no authenticity certificate, or if it does not include voter's name, voter's address, voter's municipality, voter's signature, and witness's municipality, signature, and printed name.

Result: Vetoed by Governor Evers

Because: I am vetoing this bill because I object to its prohibition on the current, long-standing practice of clerks in this state correcting minor errors and believe that this bill will almost certainly result in valid ballots never being counted. **Editorial Comment:** The clerk in Green Bay finally tattled on the group to whom the absentee ballots and their processing was turned over because of the CONTRACT SIGNED BY THE MAYOR with the Zuckerbuck gang. Do you suppose they might have been choosing which ballots to cure and which not to cure?

Wisconsin Senate Bill 292

Effect: If a municipality broadcasts canvassing proceedings live in any election, including by live stream on the Internet, the municipality shall record the broadcast, and the municipal clerk shall retain the recording for 22 months. **Result: Vetoed by Governor Evers**

Because: I am vetoing this bill because I object to creating an unnecessary and unequal burden for certain municipalities. This bill purports to be about transparency, but if that were the case, the bill would have required all municipalities to broadcast or live stream canvassing proceedings and store the recordings of such proceedings. Instead, this bill saddles communities that have, in the interest of transparency, chosen to broadcast their canvassing with the additional requirement to then store a recording of it.

Editorial Comment: Evidence of wrongdoing? What evidence of wrongdoing? You may recall that many poll locations somehow forgot to turn on their video cameras, or the videos were erased before they could be viewed by investigators.

Observations about the State Republican Convention, May 21


As many of you know, the Republican State Convention was held May 21 in Middleton, WI, almost in the heart of enemy territory. This is good for the career party guys, I suppose, but I personally prefer it to move to other venues around the state. This requires a drive through fly-over country for all those with offices and lives in Madison where there are questions about the reality of their day-to-day environment. But that is just me.

One of the hot button issues for the Winnebago GOP has been the matter of endorsements at the State Convention which precedes the primary elections every election year. As a grassroots organization, there is a lot of concern within the organization that an endorsement of a particular candidate BEFORE the grass roots voices their opinion in the primary is misplaced. The people should be telling the party who they favor rather than the other way around. The party's job is to provide as much accurate information to the grass roots as possible so the people can steer the party in the way they want to see it move.

To this end, there were some adjustments to the rules this year that did not make it impossible but made it very difficult to get the party's endorsement before the August 9th primary. To win an endorsement, a candidate needed 60% of the vote from the floor instead of just 50%. In one of the most important races this year, Rebecca Kleefisch received only 55% of the vote meaning there will be no endorsement for any gubernatorial candidates until we the people speak on August 9th. The only endorsement made by the party at the convention was for Senator Ron Johnson, who deserves every bit of support we can all give him, and who has no opposition in the primary. https://news.yahoo.com/wisconsin-republicans-refuse-endorse-partys-002002551.html

As for Robin Vos;

And now, an "I TOLD YOU SO" MOMENT:

Democrats, corporations and the liberal media repeatedly decried Georgia's Republican-passed Election Integrity Act as the next Jim Crow, but the Peach State is now seeing <u>record-breaking turnout</u> for early voting ahead of Tuesday's primary.

Last year, President Biden called the law, known as SB 202, a "blatant attack on the Constitution and good conscience," ascribed it as "Jim Crow in the 21st century" and was supportive of Major League Baseball moving the 2021 All-Star Game out of Atlanta as a response. Biden urged Congress to pass sweeping federal voting laws, including the For the People Act and the John Lewis Voting Rights Advancement Act. Biden, along with Democrats and members of liberal media, argued that the law would deny people the right to vote, especially minority Americans, and could lurch U.S. democracy off balance.

But voting in Georgia is breaking early records despite the state's "controversial new election law," as The Washington Post put it.

"I had heard that they were going to try to deter us in any way possible because of the fact that we didn't go Republican on the last election, when Trump didn't win. To go in there and vote as easily as I did and to be treated with the respect that I knew I deserved as an American citizen — I was really thrown back," she said. According to the office of Georgia Secretary of State Brad Raffensperger, there have been nearly 800,000 ballots cast by Georgians as of Friday, a number three times that of 2018 and significantly higher than 2020, an election year when voting typically increases.

Georgia is growing more diverse, and that will help Democrats. The speed of

voter registration has slowed in Georgia, which was once a model for the ability of grass-roots organizing to overcome entrenched obstacles to voting. That slowdown could hurt Democrats in the fall, although the Abrams campaign says it has identified about 42,000 Georgians who have already voted in this year's primary but did not vote in the 2018 general election. Her team also says it has found more than 100,000 Black voters who skipped the 2018 primary but have already voted this year, as well as 40,000 additional white voters and an unspecified number of new Asian American and Latino voters. Abrams lost her first race for governor against Kemp by just under 55,000 votes, so those new voters could be significant.

The Wisconsin Supreme Court in February reinstated <u>an order from a Waukesha County judge</u> that banned ballot drop boxes and stated that voters can only return their own ballot to the polling place or elections office.

But the League of Wisconsin Municipalities said in a letter to local election managers that [the] ruling isn't binding for everyone.

Woodall-Vogg suggested there would be fewer questions about who is returning ballots if Wisconsin election managers could use ballot drop boxes. (HA! Did you get that? --- Interjection by the editor)

"So many people relied on absentee ballot drop boxes in previous elections," Woodall-Vogg said.

Whoever, with the intent of interfering with, obstructing, or impeding the administration of justice, or with the intent of influencing any judge, juror, witness, or court officer, in the discharge of his duty, pickets or parades in or near a building housing a court of the United States, or in or near a building or residence occupied or used by such judge, juror, witness, or court officer, or with such intent uses any sound-truck or similar device or resorts to any other demonstration in or near any such building or residence, shall be fined under this title or imprisoned not more than one year, or both.

Nothing in this section shall interfere with or prevent the exercise by any court of the United States of its power to punish for contempt.

White House press secretary Jen Psaki on Tuesday defended protests outside the suburban homes of conservative Supreme Court justices as "peaceful to date" — despite the fact that more of the potentially illegal rallies are planned Wednesday to pressure the judges to abandon a draft anti-abortion rights ruling.

"The president's longstanding view has been that violent threats and intimidation of any kind have no place in political discourse. And we believe of course in peaceful protests," Psaki said at her daily press briefing.

"So I know that there's an outrage right now, I guess, about protests that have been peaceful to date," Psaki later added. 
"It bodes ill for a free society," he said, according to The Washington Post. It can't be that institutions "give you only the outcome you want or can be bullied" into submission.

A Pulitzer Prize-winning journalist for *The New York Times*, Walter Duranty, covered up one of the worst genocides in modern history. The atrocity I'm referring to is the Ukrainian famine of 1932-33 that was orchestrated by Soviet dictator Joseph Stalin. It killed an estimated 7 to 10 million people.

British-born Duranty had been *The New York Times's* man in Moscow from 1922 to 1936, during which he interviewed Stalin twice. For a series of reports he wrote about the Soviet Union in 1931, he was even awarded a Pulitzer Prize. Walter Duranty was given the award in 1932, the year the famine began.

Known to the Ukrainians as the *Holodomor,* "murder by famine," it is one of the least known genocides in modern history, but it is one now recognized by 24 countries, including Australia and Canada. The centers will be selected based on their:


- Excitement and willingness to participate in the program
